## **Comment:**

Dear Secretary Zinke,

On behalf of the Creation Care Team of the Rocky Mountain Synod of the ELCA, we strongly urge you to uphold the Bureau of Land Management Methane Waste Prevention rule.

Our position on this important question is deeply rooted in our Lutheran faith commitments. As recently articulated by our Presiding Bishop Elizabeth Eaton in her Earth Day 2018 message, "As members of the Evangelical Lutheran Church in America (ELCA), we share a deep love for all of God's creation and a profound responsibility for it."

At the most basic level, rescinding this rule would lead to preventable methane waste.

In Colorado, advocates from our denomination and many partner groups worked tirelessly to pass state-level waste prevention measures. As good as they are, these state level measures are insufficient by themselves. In the Four Corners area, God's people and all God's good creation exists under a massive cloud of methane which is observable by NASA from outer space. This cloud, as well as pollution from

operations in neighboring states, do not respect state lines. Air travels, and therefore we need to level the playing field with equal methane waste prevention standards nationally. For this reason, we participated in the rule-making process in 2016 by sending people to testify at public hearings in favor of this much-needed rule. So far, there have been no public hearings about the rescinding of the rule. We request an explanation of why the Department of Interior made this decision.

We know that methane and the volatile organic compounds released with it contribute to asthma, cancer, and a host of other health problems. Communities of color and people who are poor are least able to cope with these health burdens.

Furthermore, we are profoundly concerned about the damage methane does to the safe, stable climate God entrusted to us. Methane is a highly potent greenhouse gas which contributes to unstable weather patterns that interfere with farming and agriculture. While our ELCA World Hunger program evaluates the role of the Church in coping with severe weather and drought impacts on our global food system, the least we can do is stop the needlessly reckless release of dangerous methane gas into our air. We urge you not to rescind the 2016 Methane Waste Prevention rule.
